

Floorworld School Sponsorship Program Terms and Conditions

Definitions	<p>Applicant means Schools who apply for the Funding Program and members of Schools who apply for the Ongoing Support.</p> <p>Employee means an individual employed or engaged by Floorworld (including agents and contractors).</p> <p>Floorworld means Floorworld Pty Ltd ACN 051 233 964 and all Floorworld Stores Australia-wide.</p> <p>Funding Program means up to \$1000 of funding for sporting equipment, special projects and other educational initiatives as further defined below.</p> <p>Immediate Family means spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandchild, grandparent, brother, sister, step-brother or step-sister.</p> <p>Ongoing Support means a donation to a School pursuant to the Ongoing Support offer, as defined further below.</p> <p>School means kindergarten, pre-school, primary and secondary schools in Australia.</p>
Funding Program	
Program	Eligible Schools that are within a 10km radius of Floorworld can apply for up to \$1000 worth of funding for sporting equipment, special projects and other educational initiatives.
Eligibility	<p>To be eligible for the Funding Program, Applicants must be:</p> <ul style="list-style-type: none"> • A School; and • Within a 10km radius of a Floorworld store. <p>Employees of Floorworld and their Immediate Family are not eligible for the Funding Program.</p> <p>Only one Funding Program per School may be provided per annum.</p>
Process	<p>To receive the Funding Program, Applicants must:</p> <ol style="list-style-type: none"> a) Visit www.floorworld.com.au/home/community-sponsorship b) Complete the details on the form under “The Funding Program”; and c) Upload the application to www.floorworld.com.au/home/community-sponsorship along with your details and submit. <p>Floorworld will then contact the Applicant within 5 business days about the success of the application.</p>
Ongoing Support Program	
Program	For Applicants that are associated with a School, Floorworld will donate \$1 per square metre of hard flooring and broadloom metre carpet purchased to the relevant School when they upload their invoice to the website.

Eligibility	<p>To be eligible for the Ongoing Support, Applicants must:</p> <ul style="list-style-type: none"> • Purchase at least one: <ul style="list-style-type: none"> ○ Square metre of hard flooring; or ○ Broadloom metre of carpet ('Eligible Product'); • Be associated (through attending, employed, engaged by or volunteer with) a School either themselves or through an Immediate Family member. <p>Applicants can be new or existing clients to Floorworld.</p> <p>Employees of Floorworld and their Immediate Family are not eligible for the Ongoing Support.</p>
Process	<p>To receive the Ongoing Support, Applicants must:</p> <ol style="list-style-type: none"> a) Purchase an Eligible Product; b) Visit www.floorworld.com.au/home/community-sponsorship-follow-up c) Complete the details of the form nominating a School; d) Give details your invoice and the Floorworld store for the purchase of the Eligible Product and submit. <p>Floorworld will then donate \$1 per square or broadloom metre of Eligible Product to the Applicant's nominated School via electronic funds transfer. Donations will be made on a quarterly basis.</p>
